The undersigned in consideration for use of the premises at 7690 and 7694 Bradley Road, Somis, California, and for boarding, training or riding does hereby consent to acknowledge, release and agree to indemnify George Ferrante, Kathleen Ferrante, Catherine Hill, Ferrante Ranch (hereinafter collectively and individually "Ferrante"), and their employees, agents and guests from any liability arising from alleged tortuous conduct and represent and understands that:

Initial of are inherently dangerous and are likely to cause grievous personal injury or death to me and or death, injury or damage to my horse(s).

\_\_\_\_\_ I voluntarily and with full knowledge of the above risk of injury, death, or  
Initial damage, wish to voluntarily assume them and the danger they impose to me. I release Ferrante, its directors, officers, employees, agents or guests on its grounds from any alleged liability occasioned from injury, death or damage to me or death, injury or damage to my horse(s) from negligent action or inaction while I participate or spectator at any horse activity, event or competition.

Initial members or guests thereon from any and all liability including judgments or settlements, expense or cost, including attorney fees, as a result of negligent action or inaction alleged to have been committed by or to me and or death, injury or damage to my horse(s) while on its premises.

\_\_\_\_\_ I fully understand and acknowledge, agree and consent that the provisions of this  
Initial agreement will apply to my heirs, assignees, or any person seeking legal redress on my behalf. Further, that this document will remain in full force and effect until I submit an executed written revocation of it to George or Kathleen Ferrante.

\_\_\_\_\_ I have fully read and understood each of the above paragraphs initialed by me and  
Initial voluntarily agree to abide by and acknowledge same. I further understand that nothing stated to me orally shall be used to contradict, vary or alter the agreements, acknowledgments and consents expressed herein by me.

\_\_\_\_\_ Additional conditions include but are not limited to the following: No trail riding  
Initial is permitted on Saturday mornings until 1:00 p.m. or Sundays. All riders must be accompanied with an experienced trainer. No single riders will be allowed to ride. Riding on the ranch is a privilege. Ferrante has the rite to deny privilege at any time.

\_\_\_\_\_ Boarders may not hand walk horses on trails. Only riding is allowed. Riders will  
Initial be responsible for any clean up from horses on the Ferrante Ranch drive way on entrance to the ranch.
